The park requirement for this subdivision has been previously met with the platting of High Sierra Subdivision, 14th Filing.

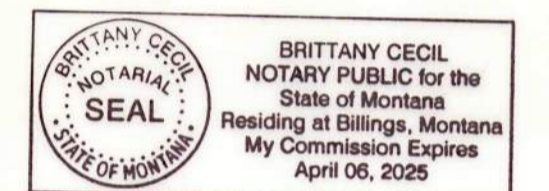

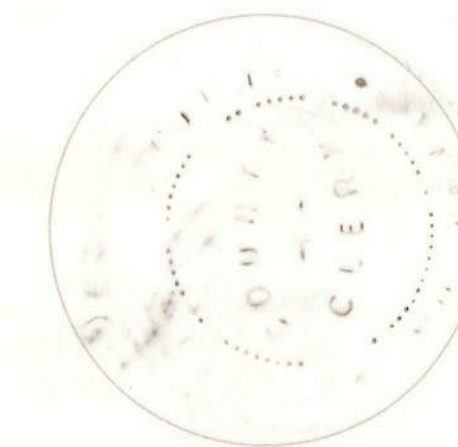

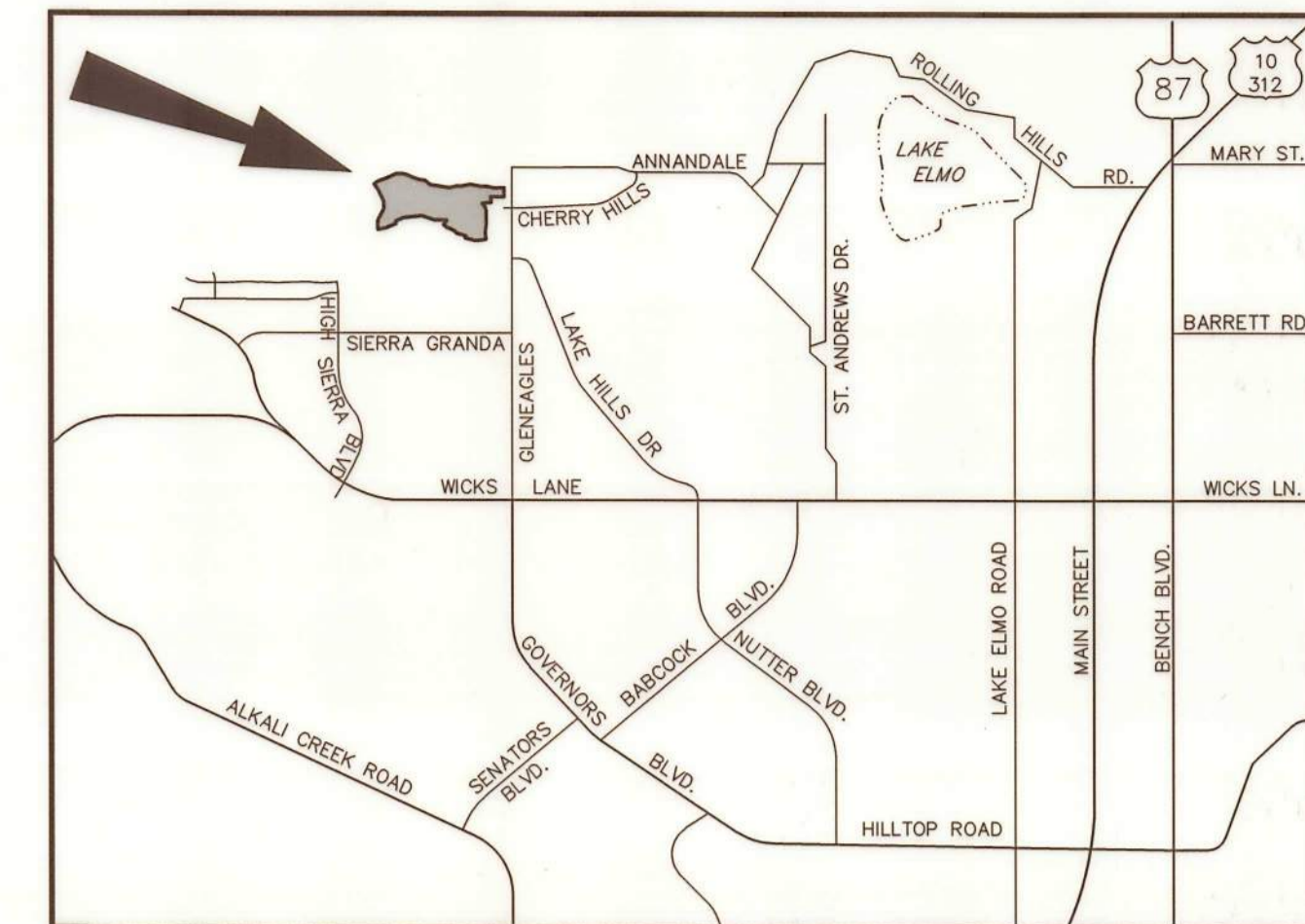

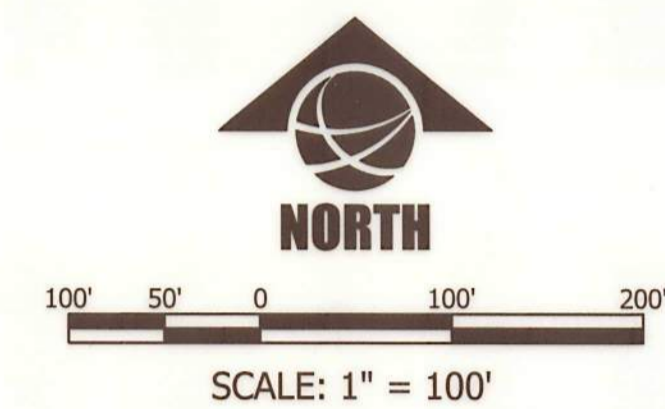

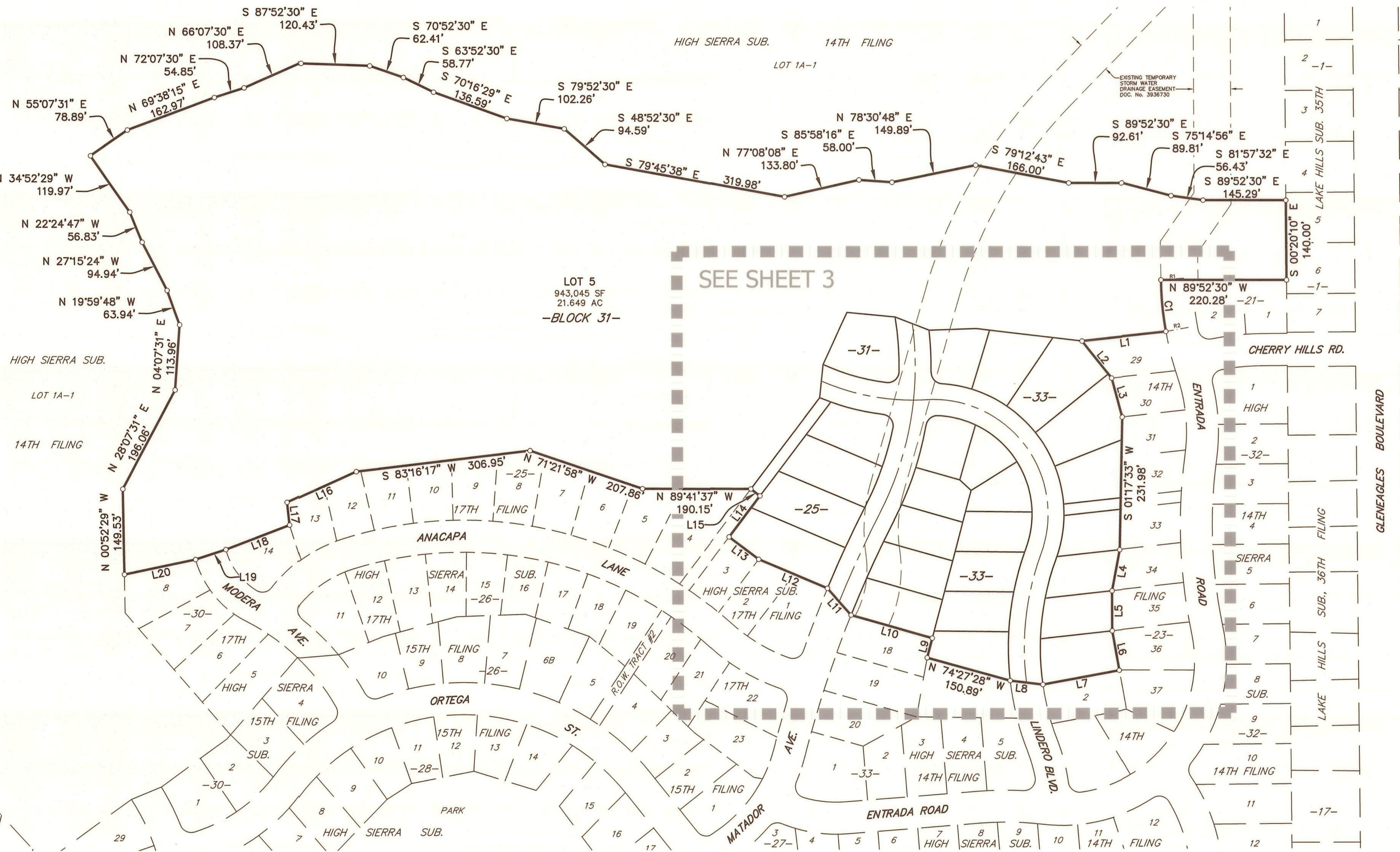
VICINITY MAP

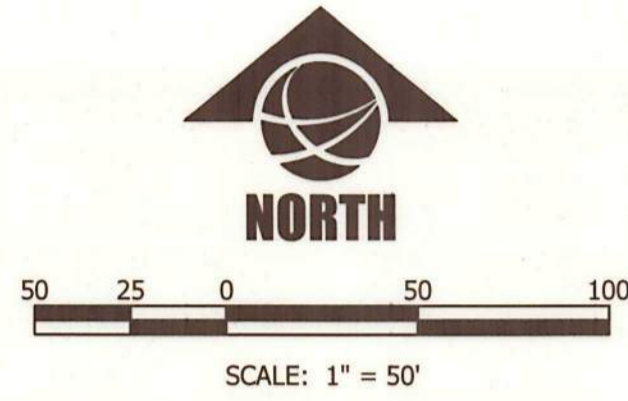

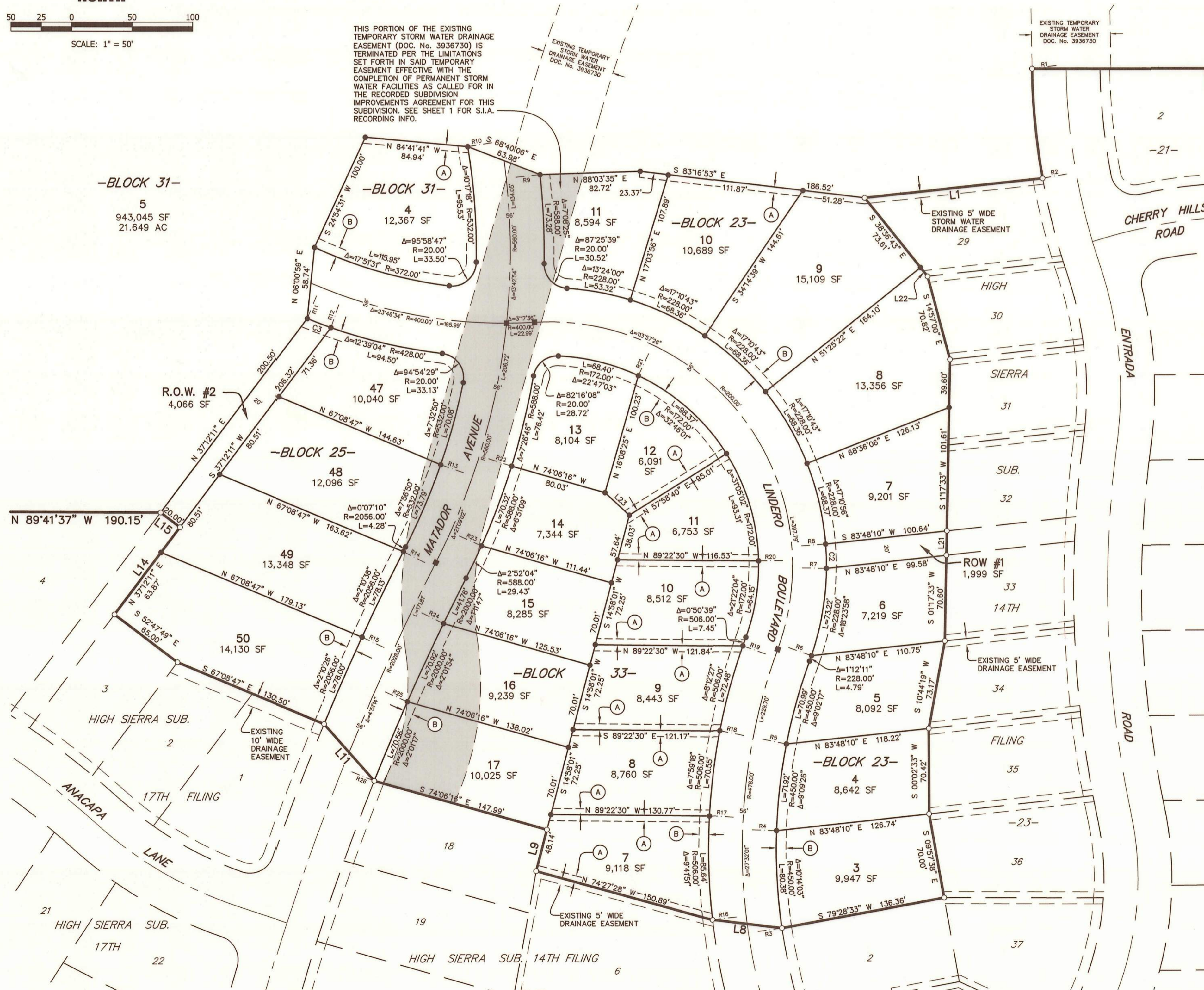
